

## Composition of ZEvA Review Panel

The Review Panel included 8 people – professors representing well-known German universities, representative of the non-academic employment sector and student representative.

### **1. Prof. Dr. Karl-Heinz Beißner, Ludwigshafen on the Rhine University of Applied Sciences**

Karl-Heinz Beißner is Professor for Management Accounting and HR Management at Ludwigshafen University of Applied Sciences (LUAS). Among his main subjects in research and teaching are Management Accounting, Financial Accounting, HR Management and Value Based Management. He is director of the two study programmes “International Business Administration” and “International Business Administration and Information Technology” at LUAS.

### **2. Prof. Dr. Richard Frensch, University of Regensburg.**

Richard Frensch is a Professor of Economics, esp. Trade and Development of Central and Eastern Europe at the University of Regensburg, and Head of the Department of Economics, Institute for East and Southeast European Studies (IOS), Regensburg. He has acted as an economic adviser to the governments of Ukraine and the Czech Republic and worked as an Economic Affairs Officer for the United Nations in Geneva.
