### Requirements for abstract design:

Volume of abstracts up to 2 pages of format A5 (14,8 x 21), type: Times New Roman, skittles 10, interval 1,0. Format Microsoft Word (file.doc). Fields: upper, lower, right - 1.5 cm, left - 2.3 cm.

Design: on the right in the upper corner of the page should indicate the name, scientific degree and academic title of the author, place of work; lower in the middle of the page is the title of the report (all capital letters, bold); last line – name of scientific supervisor, scientific title, position.

The abstracts received by the organizing committee will be published in pdf format and will be prepared as electronic collection. Participants of the conference will receive materials by April 10, 2021 at the specified email address in the application.
